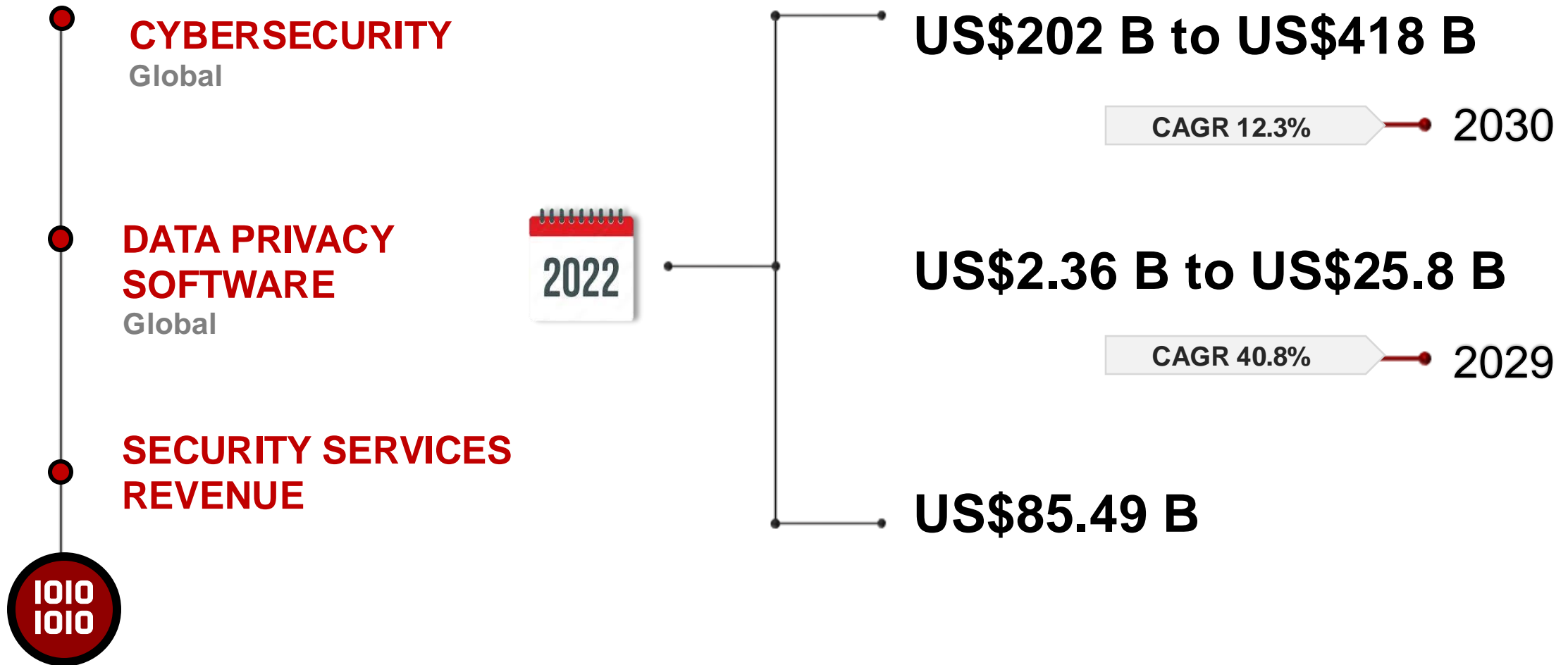

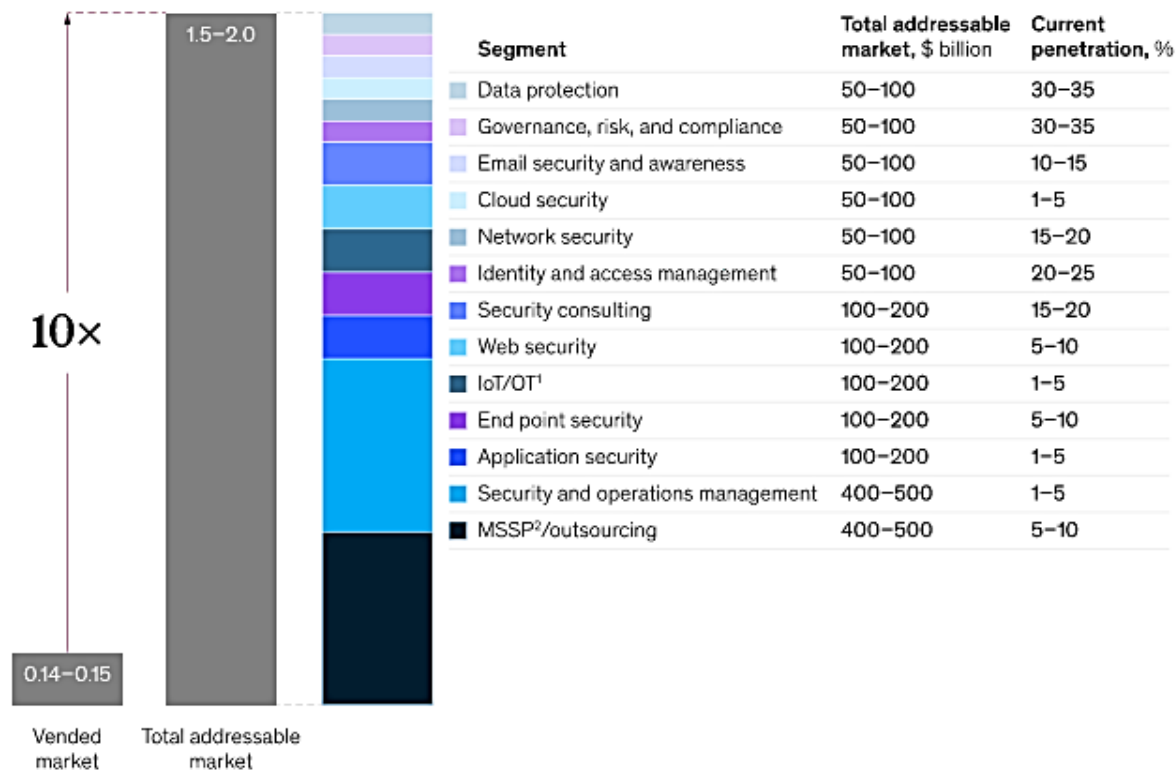

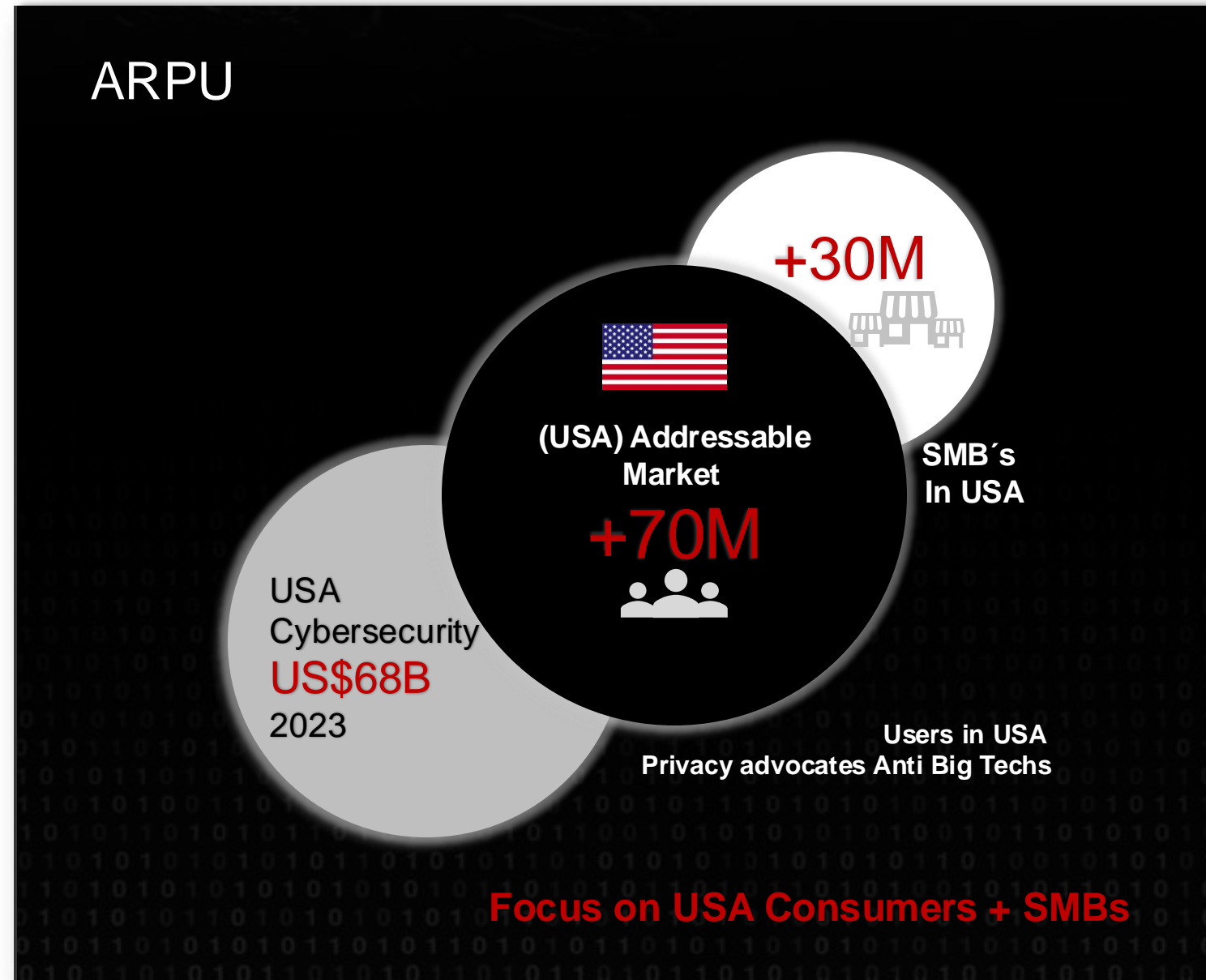
# U. S. Market OPPORTUNITY

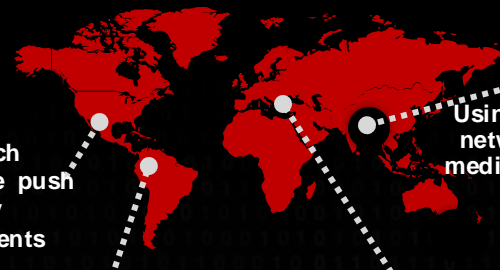

Chile experienced 304 million cyberattacks in 2021.

Chile has over 1,200 cybersecurity companies, the highest number in Latin America.

The Argentina government aims to increase cybersecurity spending to US\$60 million by 2026.

Argentina experienced a record 2.3 billion cyberattacks in 2022.



Colombia lost an estimated US\$3.47 billion to cybercrime in 2021.

Cyberattacks in Colombia increased by 81% in 2022 compared to 2021.

Mexico ranks 5th globally and 1st in Latin America in ransomware attacks, with over 30% of Mexican companies affected in 2022.

Mexico experienced over 1.24 billion cyberattacks between January and September 2022.

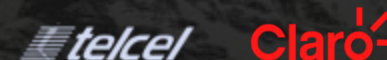

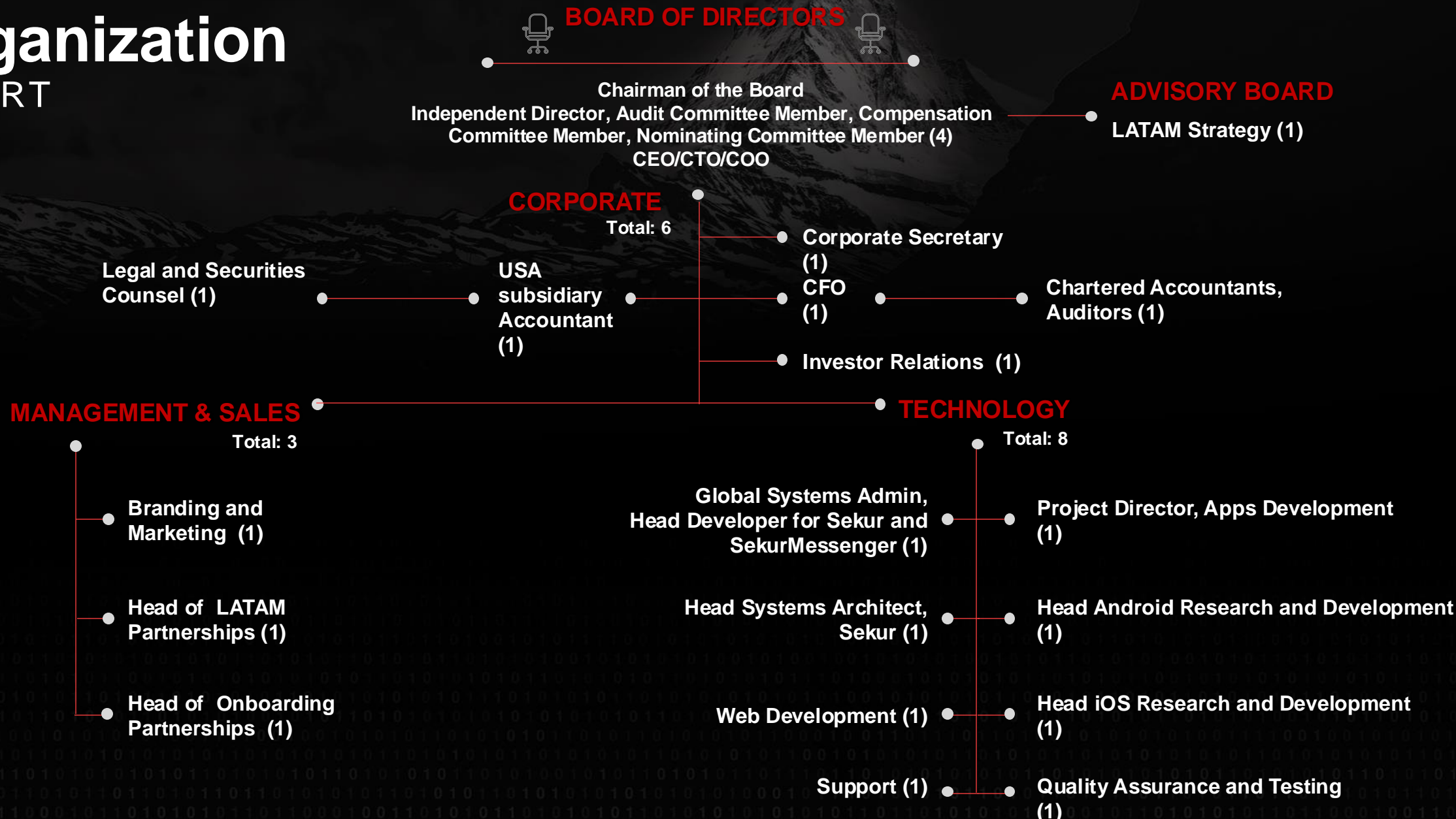
